SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The Charter High School for Law and Social Justice launched a comprehensive stakeholder engagement process to help determine how it should potentially spend federal and state stimulus dollars to address learning, COVID-19 preparedness, and COVID 19 recovery. The school launched a web-based survey in the spring of 2020 and again in 2021 that solicited feedback on the school's current progress and needs from parents, students, teachers, and community members. The school's leadership reported to its School Board's Academic Committee on the survey results. Various teams made up of parents, staff, Board members, and community members were assembled to develop our plan in the areas of need identified in the survey. In response to the question of "As we prepare for the next school year in CHSLSJ, what are the most important; academic, social-emotional, and/or mental health supports for schools to provide to serve all students (i.e., general education students, students with disabilities, English language learners, and others)?" these diverse representatives came up with a comprehensive plan on the use of these funds and how we would implement the plan. Through planning sessions and research, the collaborative teams brainstormed ideas, actions, and initiatives to implement, including using ARP ESSER funds. The assembled groups of diverse stakeholders discussed, assessed, and made recommendations associated with the following topics, including the use of funds:

- Health & Safety
- Expanding Summer School Opportunities
- · After School Options
- · Academic Intervention due to learning loss

Our school will continue to engage in meaningful conversations with all stakeholders, including parents of students from at-risk subgroups, through school notices/newsletters, Parent-Teacher Conference meetings, and Parent Association meetings. We also email blast important announcements and updates.

CHSLSJ will use the diagnostics test results to identify students needing academic intervention. We will use the following assessments: STAR and internally developed interim assessments (IAs). The aforementioned beginning of the year (BOY) assessment results will determine the students that will need small or individualized support during the traditional school day and after school. Our afterschool program will be open to all students in our school. However, small group and individualized instruction will be needs-based. Progress monitoring will occur at different intervals throughout the year (STAR and IAs will be given 3-4 times a year). Our Instructional APs will compile school-wide data on student progress to monitor the effectiveness of interventions. Data will be disaggregated by subjects/courses as well as by special populations (i.e., ELLs and SPED). We will track overall performance levels (i.e., number of students moving between groups (i.e., number of students moving between levels). Teachers will create data plans to address instructional gaps and instructional materials to support learning. We will monitor students' academic grades, attendance, and SEL in weekly grade level/SIT meetings to discuss progress and immediate intervention.

CHSLSJ plans to use the ARP funding for several interventions to address the academic impact of lost instructional time. Several initiatives include additional funding personnel to address the needs of our low-income students, students with disabilities, and our English Language Learners. The funded interventions categorized as addressing academic impact lost instruction time among the students as mentioned earlier by:

- Administrating and using high-quality assessments that are valid and reliable to accurately assess students' academic progress and assist educators in meeting students' needs, including through differentiating instruction.
- Adding additional Staff:
- Seven (Tutor and/or Reading Intervention) Instructors to assist the day-to-day instruction in the classroom.
- Director of STEM
- IT Coordinator
- Two additional Guidance Counselors
- Implementing evidence-based activities to meet the comprehensive needs of students:
- Credit Recovery Summer School Programing
- Providing After-School Program (will be provided by the tutor and reading interventionists listed in code 15)
- · After-School Tutoring/Regents Preparations (will be provided by the tutor and reading interventionists listed in code 15)
- · Tracking student attendance and improving student engagement in classrooms and school culture
- · Dedicating more resources to Advisory for instruction and building the culture of the Advisory program.
- Expand our technology offerings to our students by adding 130 Chromebook laptops to our inventory to have 1 to 1 Chromebook laptops available to all students.

CHSLSJ will monitor the progress of students using assessment results, observations, weekly grade reports, weekly attendance reports, Progress Reports (mid-way through each marking period), Report Cards (quarterly), and anecdotal notes to ensure that interventions that are put in place are meeting the academic, social, emotional and mental health needs of all of our students.

The leadership team and intervention teams will meet monthly to discuss how students progress and respond to interventions. During meetings, we will review school-wide assessment data on the assessments mentioned above to look for positive and negative trends and plan professional development for teachers to address the trends.

The School Intervention Team (SIT) will meet with teachers every week to discuss the progress of our most at-risk students. This committee will provide teachers with intervention strategies to support students at-risk for academic failure or behavioral intervention. Identifying students who need support early allows for developing a comprehensive intervention plan. Review of student progress provides periodic assessment and generates other interventions as needed.

CHSLSJ serves a student population of approximately 78% Hispanic/Latino and 20% African American with 94% free or reduced lunch and the other 6% marginal. We also have 18% SPED and approximately 19 % ENL and approximately 4% homeless. We are located in the poorest Congressional district in the US and have a very large immigrant population from the Dominican Republic and Africa. In our last graduating class 45% were first to graduate high school and go on to college.

In order to accommodate this diverse population, we moved to a co-teaching model with 2 or more teachers in a room so that we could provide more intense and small group interventions.

Upon entering CHSLSJ students are evaluated through STAR testing which evaluates and gives us the ability to determine their math levels and reading levels. We use that data to further assess and develop an intervention program. 80% of the students entering 9th grade are 2-6 years behind so intense intervention is needed for the first days in school. This intervention includes the Social-Emotional and mental health of our students which we have obtained Suite360 a comprehensive data-driven program to support those areas of need supported by additional guidance counselors and school mental health providers.

In addition to hiring more teachers we hired additional guidance counselors to support this intervention program. After the pandemic, our student body data shows over 70% are 2-6 years behind which requires intervention in every grade level.

We will monitor the progress of students using assessment results, observations, weekly grade reports, weekly attendance reports, Progress Reports (mid-way through each marking period), Report Cards (quarterly), and anecdotal notes to ensure that interventions that are put in place are meeting the academic, social, emotional and mental health needs of all of our students.
