NOW, THEREFORE, BE IT RESOLVED, that that the officers and trustees of CHSLSJ be, and each of them hereby is, individually or together, authorized and directed, in the name and on behalf of CHSLSJ, to do all such things and take all such acts and to expend such fees for and on behalf of CHSLSJ as may be necessary or advisable in order to give effect to and, generally, carry out the intent of these Resolutions including, without limitation, to execute and deliver the Request to the Board of Regents, along with any other documents in connection with the Request as may be required by the Charter School Office of the New York State Education Department, with such changes or amendments thereto as such officer or trustee deems necessary or appropriate, with such approval to be conclusively evidenced by the execution and delivery thereof by such officer or trustee; and

IT IS HEREBY FURTHER RESOLVED, that all actions of any kind heretofore or hereafter taken by any trustee or officer of CHSLSJ or any appointed or authorized person or persons authorized to act on behalf of CHSLSJ in connection with the matters contemplated by the foregoing resolutions be, and each of them hereby is, confirmed, ratified, approved and authorized in all respects.
